Discrimination Policy

Richmond Ski Club ("RSC") is a 501(c)(7) non-profit organization. It is the policy and commitment of RSC that it does not and shall not discriminate on the basis of race, color, religion (creed), gender, gender expression, age, national origin (ancestry), disability, marital status, sexual orientation, or military status, or otherwise as may be prohibited by federal and state law. Richmond Ski Club is committed to providing an inclusive and welcoming environment for all members, guests, volunteers and vendors.

Harassment Policy

Harassment is generally defined as a course of conduct which annoys, threatens, intimidates, alarms, or puts a person in fear of their safety. Harassment is unwanted, unwelcomed and uninvited behavior that demeans, threatens or offends the victim and results in a hostile environment for the victim. Harassing behavior and communication may include, but are not limited to telephone calls, emails, and other forms of communication, epithets, derogatory comments or slurs, lewd propositions, assault, impeding or blocking movement, offensive touching or any physical interference with normal work or movement, and visual insults, such as derogatory posters or cartoons. Harassment or intimidation of a member, guest, volunteer or vendor of RSC is specifically prohibited and may be grounds for revocation of membership.



Historian's Corner

Eight Facts About Copper Mountain

Whether you're a Copper rookie or are thinking about a visit for the first time, brush up on your knowledge with these facts about Copper Mountain.



- 1. <u>COPPER'S FIRST INHABITANTS WERE THE UTE AND ARAPAHO INDIANS</u> Hundreds of years ago between 1100 and 1300 AD, the Ute and Arapaho Indians lived in the area that is home to today's Copper Mountain. Join one of Copper's free <u>Ski With a Ranger</u> tours to learn more about the history of Copper Mountain and the wildlife and plants in the area.
- 2. <u>IT'S NAMED AFTER THE MINERAL COPPER</u> Fast forward to the mid-1800s when the Colorado gold rush was booming. Miners came to the area looking for gold, but instead they found copper. From then on, the mountain became known as Copper Mountain!
- **3. <u>THE COPPER MOUNTAIN SKI RESORT OFFICIALLY OPENED IN 1972</u> Chuck Lewis is Copper's founding father, he shared his vision with friends saying, "I'm gonna build me a killer ski resort." The planning and building of the resort took a few years, but it officially opened in 1972 with 26 miles of trails and 5 lifts.**
- **4.** <u>IT IS ONE OF THE LARGEST SKI RESORTS IN COLORADO</u> With 2,500 skiable acres, Copper falls in the top 10 largest ski resorts in Colorado. The terrain within these acres includes over 140 marked trails and 23 total chair lifts.
- 5. <u>IT IS HOME TO THE ONLY EARLY-SEASON, FULL-LENGTH U.S. SKI TEAM DOWNHILL TRAINING COURSE</u> Back in 2011, Copper Mountain became an official U.S. Ski Team downhill training venue with the opening of the U.S. Ski Team Speed Center at Copper. Racers can clock in speeds of up to 75 mph on this course, so keep your eyes peeled or you might miss them!
- **6.** <u>IT'S KNOWN FOR ITS NATURALLY DIVIDED TERRAIN</u> One of the best reasons for beginners to ski at Copper is the way it's divided you can start in West Village for the easiest greens and move your way east to increase in difficulty. It's one of the only naturally divided resorts in the area, so newcomers don't need to be so concerned about experts zooming past or taking a wrong turn.
- 7. <u>COPPER RECEIVES AN AVERAGE SNOWFALL OF 304 INCHES PER YEAR</u> Since Copper's opening season, March has received an average of 53 inches of snow, making it typically the snowiest month of the year.
- **8.** <u>THE LAST TIME RICHMOND SKI CLUB VISITED COPPER FOR A FULL WEEK WAS 1988/89</u> Noble McClellan and Jim Jalbert ran a Christmas week trip from December 25, 1988 through January 1, 2989. It's overdue for a full week's visit!

The Richmond Ski Club extends condolences to the family and friends of longtime member Donna Pinnix.

Former Richmond Ski Club board member and trip leader, Donna Pinnix, 82, passed away recently after a long struggle with ill health. Born in North Carolina, Donna studied art at VCU and spent much of her career in the Creative Service department at the Richmond Times Dispatch, focusing her passion on designing award winning advertising.

Donna served on the RSC Board from 1974-1979 & 1981-1982 and played an integral part when the ski club under George Winfree's leadership was incorporated by the Virginia State Corporation Commission in November 1975. In addition, she was a trip leader from 1979-1984, taking trip participants to several New England ski resorts (i.e. Sugarbush, VT & Sugarloaf, Maine) and also out West to Taos, NM. Although Donna relocated back to North Carolina in her later years, she continued to go on several RSC European ski trips and enjoyed using her camera to capture inviting door entrances in the quaint villages found on her travels.

Donna was a life-long advocate for the rights of animals and worked tirelessly to pass a state wide mandatory spay/neuter bill in Virginia. She will always be remembered for her artistic creativity, love of nature, and contributions to our organization.

Important Note: In addition to providing a valid passport, trip participants to international locations (Austria, Canada, & Switzerland) are responsible for determining their eligibility for entry to that country based on factors such as vaccination status, criminal background, etc before signing up for the trip. Please consult the trip leaders.

Participants with the IKON or EPIC pass please review the available locations and dates for your specific version of the pass you have purchased. If you have not yet purchased a pass and plan to do so, please use the link provided by your trip leader buy the pass so that the pass can be credited towards your trip.

2025 Trips

The Board is pleased to announce the following tentative trip schedule. The trip flyers will go live on the website on April 18, 2024. An e-blast will be sent to all members to announce that the trip flyers are available. Members will have one week to review the trip flyers and ask questions to the leaders. It is expected that some trips will be popular and may sell out quickly.

Trip applications will not be accepted until April 25, 2024 at 8:00 am eastern daylight time. ALL applications must be sent by email to the trip leader so that an accurate time stamp can be determined. In order to be complete, the email shall include a scan or photograph of the trip application form and deposit check(s). Spaces will be assigned in the order of receipt of applications. The official "time received" will be the time received by the trip leader, not the time sent by the potential trip participant. Additionally, emails received before 8am, for example 7:50 am, will not be considered timely. Deposit checks must be received by the leader within 7 days otherwise the application will lose its priority.

It is not acceptable for applications to be hand delivered to the trip leader or mailed earlier than the sign-up time. We will attempt to schedule a trip kickoff social that evening at a location and time to be determined. If a trip application was successfully submitted that morning, the check may be mailed or delivered to the leader at that social or other location.

The Ikon ski pass is not required but is provided as a convenience for members who may wish to purchase for multiple trips.
